

In forwarding herewith copy of letter No. 771, dated the 31st October 1890, from the Commandant, Military Police, Nága Hills Battalion, on the subject of granting language allowance to one Birbal Dás, of his battalion, for having qualified and passed in the Ao Nága language, I have the honour to invite your attention to the Government of India's letter No. 423, dated the 29th June 1889, copy of which was forwarded to this office with your Memo. In reply to your No. 5980, dated the 8th October 1890, replying to this office No. 627, dated the 6th September, asking sanction of Re. 1 per month to Birbal Dás for having passed in the Ao Nága language, I have the honour to inform you.—

- (1) That the Ao Nága dialect does not come under the heads of any "Angámi," Lhota Nága, or Kacha Nága languages, and that it is quite a distinct dialect in itself.
- (2) Birbal Dás is not a native of the Nága Hills, he is a Cachari.
- (3) If the allowance is sanctioned, the total number drawing language allowance will not come up to 10 per cent. of the battalion. There is ample provision in the budget grant to meet the expenditure under its proper head.

2. The Ao Nága country has been recently incorporated in the Nága Hills district, and it is desirable that due encouragement should be given to the study of the Ao Nága dialect, which is believed to be quite distinct from the Angámi, Lhota, and Kacha Nága dialect, the Chief Commissioner recommends its inclusion in the list of frontier languages mentioned in paragraph 2 of the above-quoted letter, rewards being paid on the same scale, and under the same conditions as are sanctioned for the Angámi, Lhota, and Kacha-Naga dialects.
