Please see the attached signal from ARO, Tezu. I feel that there is a very great advantage in members of the Research staff accompanying exploratory tours of this nature. Since they will have a unique opportunity from the anthropologist's point of view of seeing people in an almost untouched state I would like to suggest that we should lay down, as a matter almost of routine, that wherever possible, the PO's or Addl PO's going on such tours should take their ARO's with them, along with ^{the} doctor or agriculturist or whoever it may be. If we fail to do this we may be criticised later on for missing unusual opportunities of research.

2. If you agree with this I wonder if you yourself could signal to PO, Lohit and perhaps also PO, Subansiri asking them that the ARO, Lohit should, if it can possibly be arranged, accompany the Addl P.O. and the young Shukla should go either with Sailo ~~ex~~ (which in view of his study of the Tagins might be best) or with Major Kaul. I had suggested this to the AROs earlier but nothing seems to have come out of it. I put below possible draft signals which might go out from ~~a~~ you.

Dear

The Adviser has asked me to write to you about a matter which I should have thought of before. From time to time you yourself or one of your APO's goes out on column tours in unexplored or almost unexplored areas. We feel that it is most important that on these occasions you should take your Assistant Research Officer with you, along with the doctor or agriculturist or whoever else may be accompanying you.

2. There are few parts of the world today where it is possible for anthropologists to see people in an almost untouched condition. The very coming on tour of a party of officials slightly modifies the original way of life and we all know how very rapidly change is coming in every part of NEFA. Future generations will criticise us severely unless we take every opportunity to record the old life as it exists before the change comes. I know that PO's and APO's themselves have made valuable contributions to our knowledge of the people through the tour notes which they have put up at the end of their exploratory tours, but it would be a further advantage if we had somebody devoting his entire attention to recording what he can of the life and customs of the people on these occasions. Such records will be an invaluable addition to the history of NEFA.

3. I am to request you therefore, even if it may involve some additional difficulty, to include your ARO wherever it is possible on such tours of exploration.
