



Sub:- Delegation of powers to the Governor of Assam to sanction a compensatory allowances, Deputation allowances, Special Pay etc., to the staff of the N.E.F. Agency.

With reference to the correspondence resting with your letter No. Fin. 98/52, dated 11th September, 1953, I am directed to convey the sanction of the President to the delegation of the following powers to the Governor of Assam as Agent of the President subject to the condition that the allowances and special pay should not exceed the scale laid down by the Assam Government for their employees of similar status:-

(1) Powers to sanction compensatory allowances and Special Pays to N.E.F. Agency staff on the analogy of the Assam State Government staff, in cases where the N.E.F. Agency staff and the State Government staff may not be working in the same areas, upto a limit of Rs. 200/- p.m. in each case.

(2) Powers to sanction Deputation allowance to an officer of the Agency who is sent outside Assam for undergoing special training, upto a limit of Rs. 100/- p.m. in each case.

The Government of India may be furnished with six monthly statements of the cases in which the local Administration sanction the special pay or compensatory allowance or deputation allowance under authority of this sanction.






